Southern Wesleyan University is a Christian community of learners in the Wesleyan holiness tradition that recognizes God as the source of all truth and wisdom. The University seeks to create an atmosphere on campus in which members of our community – students, faculty, administrators and staff – work together toward wholeness through the integration of faith, learning and living. #### 1. Will you show respect for and live according to our Christian values, heritage and expectations?

SWU views the Bible as not only the authority with respect to our faith, but also the guide to how we should live. Scripture teaches that certain attributes such as love, joy, peace, patience, kindness, goodness, faithfulness, gentleness, and self-control are to be manifested by members of the Christian community. By contrast, Scripture condemns such attitudes as greed, lust, need-less anger, an unforgiving spirit, gender or racial discrimination and prejudice.

Furthermore, Scripture discourages certain behaviors either expressly or by implication. These include
